

2RE Competition Terms & Conditions

2RE prides itself on getting the best prizes for you and therefore some terms & conditions are placed on competitions.

The following are the terms and competitions on ALL of our competitions run on 2RE...

2RE reserves the right to amend these General Terms and Conditions at any time without notice.

1. Special Terms and Conditions may apply to a particular contest, at which time separate Terms and Conditions will be available for the contest involved.
2. No person may enter any contest more than once unless stated in Special Terms and Conditions.
3. All prizes must be collected within two months of winning. Unclaimed prizes thereafter will be placed back in the prize pool or made use of as **2RE** sees fit.
4. **2RE** will not notify winners of remaining time, it is the sole responsibility of the winner to collect their prize.

Identification must be produced to claim a prize (examples include: driver's license/passport/student card which includes a photograph).
